The Organization responded to this disaster with financial contributions to local nonprofits that were dealing directly with individuals and nonprofits significantly affected by the fire.

4c (Code: ) (Expenses \$ 60,627 including grants of \$ 53,781 ) (Revenue \$ ) Care & Comfort Kits (formerly Assault Survivor Kits) provides clothing kits and hygiene kits to survivors of assault, individuals experiencing homelessness, and those in crisis. The goal is to offer comfort and help restore dignity to these survivors. Kits are distributed through various alliances in the Pasadena community.
